Anirudh Krishnan

Anirudh Krishnan is an Advocate of the Madras High Court and is qualified as a Solicitor of England and Wales. After graduating from NALSAR University, Hyderabad he worked at Clifford Chance, London as part of the arbitration team. He completed the BCL at the University of Oxford before joining the Madras Bar.

He has written extensively on Indian arbitration law and is the Chief- editor of Justice R.S. Bachawat's Law of Arbitration and Conciliation- a leading commentary on Indian arbitration law, which has been cited by a number of Indian Courts. Among other cases he was involved in the review of Bhatia International v. Bulk Trading by the Constitution Bench of the Indian Supreme Court.

Adrian Winstanley is the Director General of the LCIA and a member of the LCIA Court and Board.
