## Construction and Engineering

Hannah has experience of disputes involving payment issues, defective workmanship as well as delay and disruption claims, and is familiar with standard form contracts used in the construction industry, in particular JCT and NEC contracts. She has additional experience of nuclear-related projects involving design, safety case issues and environmental issues. She also has a growing practice in energy matters, in particular oil and gas-related disputes. Notable cases include working as a junior in multi-million pound complex claims as well as contractual disputes (including arbitration and adjudication), professional negligence issues and statutory claims involving contractors and project designers.

- Advisory work for local authorities and construction professionals on cladding issues and fire safety management
- Acting for a management firm in a dispute arising from a private finance initiative (PFI) contract, including such issues as fire compartmentation, fire safety management and unavailability provisions
- Acting for a contractor in a claim brought by the developers of a disused power station
- Acting for a main contractor in delay and disruption claim arising in the course of a multi-million pound infrastructure dispute in East Africa
- Advisory work for a local authority in respect of a waste treatment disposal plant
