Richard Wald was called to the bar in 1997. He specialises, and is ranked by the main directories, in the following areas of law: Planning, Environmental, Energy, Administrative and Public Law (including Local Government). He was General Editor of Thompson's Encyclopaedia of Environmental Law from 2004-2015 and continues to edit the Bulletin of Environmental Law. He is a contributor to Tromans on EIA Law and Practice, Tromans on Nuclear Law and and Co-author of Butterworth's Highways Law and Practice. He was appointed an Assistant Boundary Commissioner in 2016 and to the AG's B-Panel of Junior Counsel to the Crown in 2009.



James Burton specialises in planning and environmental law and related civil liability. In addition to his core planning and environmental work, James has substantial expertise in compulsory purchase, energy, claims under Part 1 of the Land Compensation Act 1973 and national infrastructure/Hybrid Bill work. James has a wealth of public inquiry and High Court/Court of Appeal experience. He has also acted as an investigating officer in respect of allegations of misconduct in public office and has recently made numerous appearances before the House of Commons Hybrid Bill Select Committee considering High Speed 2 (and more recently still has appeared before the House of Lords Select Committee considering the same Bill). James was named Chambers & Partners Environmental and Planning 'Junior of the Year' at the 2015 Chambers Bar Awards.
