Richard is also a leading commentator, a case editor of the Journal of Planning and Environment Law and the author of books including Planning Enforcement, Historic Environment Law and Planning Permission. In 2015 he was appointed by the Housing and Planning Minister as the sole lawyer member of the Local Plans Expert Group.

She is an experienced inquiry advocate and in 2014 acted for the local parish councils in the Redhill Aerodrome inquiry which led to the Court of Appeal decision on the meaning of "any other harm" in the Green Belt test. Significant cases include R (on the application of Save Britain's Heritage and the Victorian Society) v Sheffield City Council [2013] EWCA Civ 1108 and Wind Prospect Developments Ltd v Secretary of State for Communities and Local Government [2014] EWHC 4041. In 2014 she was named as "highly recommended" in Legal Week's Stars at the Bar profile of the most promising junior barristers under 10 years call and is currently ranked 6th in planning magazine's top juniors under 35.
