- ***X v Y (2019) FA Rule K Arbitration***

Party nominated panel Arbitrator (with Mark Hovell of Mills & Reeve as Chair and David Casement QC) in FA Rule K arbitration arising out of an alleged breach of a player representation contract. Settled.

- ***Cillian Willis v Sale Sharks & Ors (2017-2019)***

Instructed by DWF on behalf of Sale Sharks in a case brought by a former professional rugby player, for damages arising out of alleged negligent management in relation to concussion injuries suffered during a rugby match. Believed to be the first claim of this kind in the UK following on from the class-action concussion case brought by more than 4,500 former NFL players in the USA. Ultimately discontinued against Sale Sharks following interlocutory hearings.
