

Cases of note

Her experience includes:

- Junior Counsel representing the OEP in the Supreme Court in *R* (on the application of Finch on behalf of the Weald Action Group) (Appellant) v Surrey County Council and others (Respondents) an appeal concerning the environmental impact assessment of Scope 3 emissions, i.e. greenhouse gas emissions from the use of fossil fuels extracted as the result of a project. (Led by Stephen Tromans KC.)
- Junior counsel in *R* (on the application of Samuel Smith Old Brewery (Tadcaster) and others) (Respondents) v North Yorkshire County Council (Appellant) [2020] UKSC 3 an appeal concerning the meaning of preserving "the openness of the Green Belt" in the context of mineral extraction. (Led by Peter Village KC, James Strachan KC and Ned Helme.)
- Junior counsel in a judicial review challenging the grant of planning permission to two intensive meat poultry buildings grounds included a failure to: assess the likely significant effects of ammonia emissions; the impacts of manure spreading and the impacts of the proposed development in terms of its contribution to climate change.
- Advises large organisations on the impact of draft legislation including the draft provisions of the Environment Bill (as it then was) and the Levelling-up and Regeneration Bill.
- Carried out a large scale review of the effectiveness of the environmental assessment regimes EIA,
 SEA and HRA.
- Acting as junior counsel in a judicial review regarding the Oil & Gas Authority's strategy, concerning new net zero obligations.
- Assisting as junior counsel in a judicial review challenge to the development of a third runway at Heathrow airport.
- Sole counsel in a trial concerning the destruction of property under the Clean Neighbourhoods and Environment Act 2005.
- While at the Supreme Court as a Judicial Assistant Ruth assisted with several cases relating to environmental law. Those cases included: *R (on the application of Lancashire County Council); R (on the application of NHS Property Services Ltd)* [2019] UKSC 58; *R (on the application of Newby Foods Ltd) v Food Standards Agency* [2019] UKSC 18 and *London Borough of Lambeth v Secretary of State for Housing, Communities and Local Government and others* [2019] UKSC 33.
