## Administrative and Public

Tom is interested in all areas of public law, particularly civil liberties and human rights, equalities, education, social security, immigration and asylum, housing, community care, electoral, regulatory and disciplinary, and actions against the police.

He appears for both claimants/applicants and defendants/respondents and was appointed to the Attorney General's London C Panel in January 2019 and the London B Panel in July 2021. He was appointed to the Equality and Human Rights Commission's C Panel in May 2019. He is a Consultant Editor of the Election Law volume of Halsbury's Law of England and General Editor of Shackleton on the Law and Practice of Meetings.

## Cases of note

- ***R (A Professional Body) v Secretary of State for Health and Social Care (2023)*** – junior counsel in challenge to the Privy Council Advisors' recommendation to the King as to an award of Royal Charter status to another professional body.
