A claim to dismiss an application in the Court of Protection for orders in relation to a young person detained in hospital under the Mental Health Act 1983.

R (On the application of Lancashire CC) v Secretary of State for Health [2021] EWHC 268

#### (Admin)

A dispute between local authority concerning responsibility for funding accommodation and care for a man that had suffered a catastrophic brain injury.

R (On the application of Nettleship) v NHS South Tyneside CCG [2020] EWCA Civ 46 A judicial review claim in relation to the reconfiguration of hospital services involving a challenge to the consultation process carried out by reference to s14Z2(2) of the National Health Service Act 2006.

### Warrington and Halton Hospitals NHS Foundation Trust v GTI [2020] EWCOP 28

An urgent medical treatment case in which Mr Justice Williams made declarations that GTI lacked capacity to make decisions as to the provision of life-sustaining food and fluid together with anti-psychotic medication and authorised the same using such force as was necessary and in GTI's best interests.
