#### D. AMICUS CURIAE

Appointed Amicus Curiae by the Bombay High Court in 14 matters:

- i. **Public Interest Litigation No. 62 of 2014** (Order dated 6<sup>th</sup> January 2017, Coram: Dr. Manjula Chellur, C.J. and G.S. Kulkarni, J.) with respect to the issue of parking, traffic, and congestion in Mumbai.
- ii. **Public Interest Litigation No. 104 of 2014** (Order dated 7<sup>th</sup> December 2016, Coram: Dr. Manjula Chellur, C.J. and M.S. Sonak, J.). This PIL dealt with the aspect of fire safety under extant provisions of law including the MMC Act, DCR, National Building Code etc. and policy for providing compensation to deceased / injured fire fighters.
- iii. **Appeal No.67 of 2014** (Coram: S.J. Vazifdar, J. A formal Order of appointment was not passed. The appearance as Amicus Curiae is noted in the Order dated 13<sup>th</sup> October 2014 passed in Appeal No. 67 of 2014 and subsequent Orders passed therein). The appointment as Amicus Curiae was to assist the Court by appearing on behalf of the Appellant who was appearing as a party in person.
- iv. **Company Application No. 429 of 2013** (Order dated 20<sup>th</sup> January 2016, Coram: K.R. Shriram, J.). The appointment as Amicus Curiae was to assist the Court in determining whether leave under Section 446 of the Companies Act, 1956, was required to be taken for proceedings under the Foreign Exchange Management Act, 1999 against the Company (in liquidation).
- v. **Arbitration Petition (L) No. 1000 of 2018** (Order dated 7<sup>th</sup> September 2018, Coram: S.J. Kathawalla, J.). The appointment as Amicus Curiae was to assist the Court in

view of the serious nature of allegations made in a petition under Section 34 of the Arbitration and Conciliation Act, 1996.

- vi. **Notice of Motion (L) No. 1436 of 2017 in Suit (L) No. 408 of 2017** (Order dated 20<sup>th</sup> February 2018, Coram: S.J. Kathawalla, J.). The appointment as Amicus Curiae was to assist the Court in a matter where the developer was unable to complete the project in question, thereby causing grave hardship to the rehab occupants of the building under redevelopment.
- vii. **Public Interest Litigation No. 176 of 2015** (Order dated 2<sup>nd</sup> November 2017, Coram: Dr. Manjula Chellur C.J. and M.S. Sonak, J.). This PIL was taken up by the Hon'ble Bombay High Court on its own motion and dealt with the issue of farmer suicides in Maharashtra.
- viii. **Company Application No. 171 of 2015 in Company Petition No. 549 of 2012** (Order dated 4<sup>th</sup> September 2015, Coram: S.C. Gupte, J.). The appointment as Amicus Curiae was to assist the Court which considered the legal and statutory powers/basis pursuant to which, the Company Court may order a deposit towards advertisement and publication of a Company Petition.
- ix. **Testamentary Petition No. 2158 of 2017 in Will No. 925 of 2017** (Order dated 24<sup>th</sup> October 2018, Coram: G.S. Patel, J.). The issue involved in this Petition was whether Section 67 of the Indian Succession Act 1925, correctly read with Section 57 and Schedule III, has any application to "any Will made by a Hindu", irrespective of where that Will is made and irrespective of the location of the property to which that Will relates.
- x. **AD-HOC NO. WP-LD-VC-178 OF 2020 and AD-HOC NO. WP-LD-VC-197 OF 2020** (Order dated 24<sup>th</sup> July 2020, Coram: S.J. Kathawalla J. and R.I. Chagla J.) These Writ Petitions challenged the State Government's notification prohibiting persons above the age of 65 years from participating in Film / TV and OTT shootings.

- xi. **OS-WP-LD-VC-188 OF 2020** (Order dated Order dated 24<sup>th</sup> July 2020, Coram: S.J. Kathawalla J. and R.I. Chagla J.) This Writ Petition was filed by an association of practicing valuers challenging SBI's policy of empanelment which, *inter alia*, prescribed an age limit of 70 years for empanelment and required prospective valuers seeking empanelment to execute an indemnity in favour of SBI.
- xii. **Suo Motu Civil Writ Petition No. 1 of 2020** (Order dated 24<sup>th</sup> September 2020, Coram: Dipankar Datta C.J. and G.S. Kulkarni, J.) The Bombay High Court has taken Suo Motu cognizance of building collapses in Maharashtra and preventive measures which can be taken in this regard.
- xiii. **Civil Writ Petition (L) No. 7838 of 2021** (Order dated 22 June 2021 Coram: S.J. Kathawalla and Milind Jadav, JJ.). The Petitioners seek compensation on account of a government infrastructure project affecting their customary right to fish in the Thane Creek.
- xiv. **Appeal from Order (St) No. 2662 of 2023** Order dated 31 January 2023 (Coram: G.S. Kulkarni, J.) The matter involved interpretation and application of the judgment passed in Suo Motu Civil Writ Petition No. 1 of 2020 where Sharan Jagtiani was appointed as Amicus Curiae.
