#### **Definitions**

- Article 2 of the Convention on Biological Diversity defines "biological diversity" as:
  - "[T]he variability among living organisms from all sources including, inter alia, terrestrial, marine and other aquatic ecosystems and the ecological complexes of which they are part; this includes diversity within species, between species and of ecosystems."

25 Year Environment Plan (page 58):

- "Biological diversity, or 'Biodiversity', is simply the variety of life on Earth – the variety of ecosystems or habitats, of species and of the genetic diversity they contain. We value wildlife in its own right but biodiversity also underpins much of the economic and social benefit we gain from nature."

  - Policy for embedding an "environmental net gain" principle for development
  - Commitment to consult on mandatory "biodiversity net gain"

#### Commencement of Statutory BNG

- Commencement of BNG:
  - Town and Country Planning Act 1990 development: 12 February 2024 (and 2 April 2024 for non-major developments)
  - Planning Act 2008 development: Due late November 2025

  - Collection of 26 (and counting) separate pieces of guidance from Defra, Natural England,
     and the Department for Levelling Up, Housing and Communities
  - Includes lengthy Planning Practice Guidance on BNG
- British Standard BS 8683:2021
- Planning Advisory Service suite of resources on BNG for local authorities

- The Submission and Determination of Planning Applications and the Statutory BNG Condition
- The Biodiversity Gain Plan



## BNG for TCPA 1990 development (3)

- Modifications for irreplaceable habitats
- Modifications for phased development
- Modifications for section 73 applications
- Minerals
- Monitoring and enforcement
- Plan-making and BNG



#### BNG for NSIPs

- Due to come into force late November 2025
- Amendments to ss 103-105 of the PA 2008 and new Schedule 2A
- Appears Government is envisaging that BNG for NSIPs will operate in a broadly similar way to the regime for TCPA 1990 development, but still a work in progress.



#### Marine Net Gain

- Legislation governing BNG currently limited to development on land and intertidal locations.
- Once the new Schedule 2A to the PA 2008 is in force, the Secretary of State will have power (under paragraph 11 of that Schedule) by regulations to apply the Schedule, with or without modifications, to PA 2008 development in the English marine region.
- 2022 'Consultation on the Principles of Marine Net Gain' and 9 December 2023 Government Response.



#### **Environmental Net Gain**

- The policy in the 25 Year Environment Plan
- 2023 Government Response to MNG consultation definition of Environmental Net Gain:
  - "Improving all aspects of environmental quality through a scheme or project. Achieving environmental net gain means achieving biodiversity net gain first, and going further to achieve net increases in the capacity of affected natural capital to deliver ecosystem services"



#### Case Law on BNG

- NRS Saredon Aggregates Ltd v Secretary of State for Levelling Up, Housing and Communities [2023] EWHC 2795 (Admin):
  - Inspector's Appeal Decision dated 5 May 2023.
  - Inspector dismissed an appeal for minerals development in which BNG of nearly 40% was secured. In so doing, he had afforded "only moderate weight" to the BNG on the basis that "some of the biodiversity net gain that would be achieved is required to meet national policy and future legislative requirements in order to mitigate the environmental impact of the development".
  - Eyre J found that to be an error of law, since the statutory regime for BNG had not, at the time of the Inspector's decision, commenced and would not operate retrospectively.



## Concluding Thoughts

- New regime
- Level of effectiveness will only be ascertainable in the long run
- Is 10% the right level?
- Is 30 years the right timescale?
- What will be the level of burden of the regime?
- How will the regime change over time?
