Paul Craig QC FBA is Professor of English Law at St John's College, Oxford and is an academic associate of 39 Essex Chambers. His research covers Administrative law, Constitutional Law, Comparative Public Law and EU Law. He is the alternative UK member on the Venice Commission for Law and Democracy. His most recent research has focused on the legal implications of the EU financial crisis, the foundations of EU Administrative law and review of discretion in UK law.

David Feldman QC FBA is the Rouse Ball Professor of English Law, University of Cambridge, and a Fellow of Downing College, Cambridge and is an academic associate of 39 Essex Chambers. He previously taught at the Universities of Bristol and Birmingham and the Australian National University, was the first Legal Adviser to the Parliamentary Joint Select Committee on Human Rights (2000-2004), and a Judge of the Constitutional Court of Bosnia and Herzegovina (2002-2010). He writes extensively on constitutional and administrative law, civil liberties and human rights, and the relationship between national and international legal systems.

The Rt Hon Sir John Laws has been a Lord Justice of Appeal since January 1999, having been a High Court Judge since 1992. Before that he was First Junior Treasury Counsel, Common Law from 1984-92 whilst a tenant at 39 Essex Chambers. He is the President of the Administrative Law Bar Association and of the Bar European Group. He was Treasurer of the Honourable Society of the Inner Temple, 2010.
