




### Health data and the GDPR - recap



Special category data; Lawful basis, Article 6; Plus: identify Article 9(2) exemptions; Article 9(2) list includes processing for employment, health, public health and scientific purposes; Read with Sch. 1 of DPA

2018.

# Recap (2)



- These conditions exist alongside the requirement to consider:
- Purpose limitations;
- Accuracy and data minimisation;
- Security measures;
- Retention periods;
- Privacy notices, etc.



## Testing Staff at Work

•Consider GDPR and data protection impact assessment;

 Necessary of testing - who and by whom?

•GDPR categories, including Article 9 - Art (2)(b) and Schedule 1, para. 1 of DPA 2018;

•Transparency and privacy notices;

•Security of personal data held.

### Notices enabling Sharing of Confidential Patient Information

Department of Health & Social Care 39 Victoria Street London SW1H 0EU

To: Organisations providing health services General Practices Local Authorities Arm's Length Bodies of the Department of Health and Social Care

20 March 2020

- Notice *requiring* the sharing of confidential patient information for Covid-19 purposes (England and Wales);
- Widely defined purpose;
- Enables sharing between health service employees/ contractors; public authority employees/contractors working in 'communicable disease surveillance';

In effect until 30 September 2020, record keeping required.



# Guidelines

#### Guidelines 03/2020 on the processing of data concerning health for the purpose of scientific research in the context of the COVID-19 outbreak

Adopted on 21 April 2020
