Training Workshop in use of FIDIC Forms of Contract

This workshop will consider aspects of the FIDIC Rainbow Suite of Contracts 1999, including how the contracts work and the principal rights and obligations of the parties to a contract under the Red, Yellow or Silver Books. The main changes to the FIDIC Rainbow Suite of Contracts since the 2017, including in their implications for parties, administrators and dispute resolvers, will also be considered.
