Tom frequently appears in special educational needs (SEN) and disability discrimination cases, largely, but not exclusively, for local authorities and schools. Tom has experience in the Upper Tribunal in relation to SEN appeals, as well as extensive experience of school exclusions, admissions and transport (Tom has represented both schools and parents at exclusions hearings and has extensive experience of clerking exclusions and admissions hearings). He has experience of defending local authorities in judicial review proceedings concerning school admissions and attendance, and has provided training to local authorities on all aspects of SEN and school exclusions. Tom also has experience in the field of higher and further education, including academic misconduct, student finance and judicial review proceedings in respect of teacher qualifications.

Tom has developed particular expertise on the powers and duties of local authorities under Part III of the Children Act 1989, having successfully represented a number of local authorities in judicial review cases in this area over the last twelve months: *MN & KN v London Borough of Hackney* [2013] EWHC 1205 (Admin), *N & N v London Borough of Newham & Essex County Council* [2013] EWHC 2475 (Admin) and *R (OO) v London Borough of Hackney* CO/11974/2013 (permission decision, 29 November 2013). Tom has also provided advice, training and representation on all aspects of the "leaving care" regime under the 1989 Act.

MENTAL HEALTH AND COURT OF PROTECTION

Tom has experience of mental health review tribunals and providing advice on various aspects of mental health law, including in respect of guardianship orders and breaches of the Mental Health Code of Practice in regard to long term seclusion.
